



1. On race day, under no circumstance are you permitted to give your bib to another person. The safety of our athletes is paramount, therefore we need to ensure we have correct details of all our runners on course.

2. I have read the **Terms and Conditions on the website** in particular regards **refunds and transferring my registration**

3. As the trail crosses private landowner property, it is also important to understand the below waiver:

I accept that I participate in the "Fiordland Trails Trust Event", in either the Meridian Hydro Half Marathon or Mitre 10 Te Anau 10km, entirely at my own risk.

I agree to accept responsibility and/or liability for any damage I may do to myself, fellow competitors, and/or third parties, equipment and possessions.

I waive all and any liability or claim against the organisers, sponsors, landowners, officials and assistants in connection with the event.

I indemnify the organisers, sponsors, landowners, officials and assistants against any claim arising from my actions or inactions.

Under no circumstances will the Organising Group, its sponsors, or any party associated with the event including their employees or agents, have any responsibility or be liable in contract, tort or otherwise, to compensate any competitor or any other party that is directly or indirectly associated with that competitor, for any loss, (including financial loss), injury, damage or death arising directly or indirectly from:

(a) their intended or actual participation in the event and its related activities;

(b) any act, omission, error or delay (whether negligent or otherwise) of the Organising Group, sponsors or any party associated with the event or its employees or agents.

4. Competitors authorise their name, voice or picture, or any information given on their entry to be used without payment in any broadcast, telecast, advertising, promotion or in any other way relating to this event pursuant to the Privacy Act 1993.

Competitors agree to abide by the rules of the race and to allow the sponsors to use photographs taken during the event to advertise their products or to promote the event, at no cost to the sponsors.

Any participant aged under 18 years must ensure the Terms and Conditions are accepted and agreed to by a legal guardian/parent.

Please note the event website (www.fiordlandtrails.nz/events) may contain other terms and conditions that apply to the event. By participating in the event, competitors also acknowledge acceptance of the terms and conditions set out on the event website and within the event's online registration.

Refunds

- Withdrawals up to 01 July 2021 will receive a 50% refund (or defer to 2022 event, and incur a \$20 administration fee)
- Withdrawals from 02 July to 01 August 2021 will receive a 25% refund (or defer to 2022 event, and incur a \$20 administration fee)
- There will be no refunds or deferments after 01 August 2021
- Any request for a refund must be made in writing

Transfers

- Transfer of a registration to another person is only available up to 01 August 2021, and will incur a \$20 administration fee
- Any request for a transfer must be made in writing

Cancellation policy

- In the event of cancellation of the race due to any adversity, be it weather, flooding or any other force majeure, including restrictions due to Covid 19, the organising committee reserves the right to decide whether to defer entries to the 2022 event (after which point there would be no refunds), and/or to make arrangements for entrants to request a **60%** refund. This will be communicated to all participants via email.
